We have all read about the elimination of the estate tax. We've seen how the Republicans, at the behest of extraordinarily wealthy families and their lobbyists, have reframed the issue as the Death Tax and erroneously convinced millions of Americans that their middle class estate would be subject

to the tax.

The Family Farm and Dad's Drugstore are lost to *Snidely Whiplash* they scream, even though it ain't so. At most, 2.1% of estates are subject to the tax, but the Republicans would have us believe that you and I will lose our knick-knacks to the estate tax. This tax must go NOW, they insist.

But I never understood how they proposed to make up the difference in tax revenue.

The truth is that the repeal of the Estate Tax passed by the

House, and now under consideration by the Senate, will eliminate the "stepped-up basis" for valuing inherited assets. To put things as simply as I can, the Mars family, the people who brought you M&Ms, and their ilk will not owe any inheritance taxes, but when you sell the family home that your parents bought in the 60's, you will pay capital gains tax on the difference between what they paid for it then and what you sell it for now.

Under current law, you would receive the house at the “stepped-up” basis of today’s value. You would not owe any inheritance tax because your parents did not leave you millions. And when you sold the house, you would owe no capital gains tax. The same principle would be true for the nest egg of savings and stocks that your parents left you. No capital gains tax under today’s law, but you pay hefty capital gains under the new law. As Albert Crenshaw said in Sunday’s *Washington Post* Business section, our interests are not exactly aligned with those of

the Mars family and others at their level.

This is what they are doing behind the scenes while they try to convince the nation that the real issue is federal judges who are not sufficiently persons of faith, their faith.

Polluter of the Potomac

Taking the children fishing is a rite of passage. Unfortunately, for Old Town residents such as Jonathon Krieger, who takes his two sons fishing along the Potomac, the rite comes with a warning – don't eat what you catch.

"It's really difficult telling my two little boys that we can't eat the striped bass, largemouth bass, catfish and other fish we catch because of mercury pollution," Krieger says. A major source of the mercury pollution to which Krieger referred comes from the Mirant power plant in Alexandria. We know this because, according to the Environmental Protection Agency, U.S. power plants – like Mirant's – are responsible for 41 percent of mercury emissions in this country.

Nearly a year ago, the Environmental Protection Agency and the Food and Drug Administration issued public warnings about the danger of eating fish with high levels of mercury. Health complications include learning disabilities in children and blood pressure instability in adults. Pregnant women and children are especially vulnerable to mercury contamination.

Yet now the EPA is undercutting efforts to keep high levels of mercury out of our air and water.

Under the bipartisan 1990 Clean Air Act amendments, the Mirant power plant in Alexandria would have been required to reduce its emissions of airborne mercury by about 90 percent during the next three years. But after recent rule changes by the EPA, and under a proposed version of the Clear Skies Initiative, the Mirant plant will not have to reduce its mercury emissions one iota.

Last month the EPA took the bizarre step of trying to remove power plants from the list of sources that must reduce "hazardous air pollutants," including mercury. In doing so, the agency enabled these plants to avoid the more stringent and timely reductions of mercury emissions that other major sources of mercury, such as medical waste incinerators, have had to meet. This change in classification carried out by regulatory fiat allows polluting power plants to delay the costs associated with reducing mercury emissions until 2018 – at the expense of the public's

health. The EPA's new rule also will allow some power plants to forgo cleanup by buying pollution "credits" from cleaner facilities.

Now Senate Republicans are trying to exempt from mercury emission reductions any power plant that emits fewer than 30 pounds of mercury per smokestack per year. Roughly 40 percent of the nation's power plants fall into that category, including the Mirant plant in Alexandria. Not only would the plant not have to curb its mercury emissions under this proposal, it would be able to sell its pollution credits to other plants. Yet Mirant's five smokestacks together emit about 83 pounds of mercury a year.

The neighbors of the Mirant plant understand the health threat it represents. I have been working for years with the Alexandria City Council, local leaders and environmental organizations to find ways to reduce mercury emissions from the plant; barring that, we want to find a way to shut it down.

What's more important – the health of the people of this region or a polluter's profit margins?

Saslaw reports on legislative moves, outlines priorities

Let me begin by speaking to our priority needs. This year, while we allocated \$848 Million for a one time "shot" for transportation (\$265 M is earmarked to pay off projected completed prior to last June), we have still not addressed the needs of a long term solution to Virginia's transportation infrastructure. Most interesting, one proposal to "solve" the question of adequate funding for transportation was to heavily fine repeat traffic offenders up to \$4000 over 10 years (or the parents of drivers that could not pay the fine for such things as driving 72 in a 65 MPH zone).

The General Assembly, (mostly the House of Delegates) is full of people who think this state can be run without any additional taxes and/or reducing state revenue. The House of Delegates voted to restart the final phase out of the car tax, which when fully implemented would almost equal what we spend on all of the state's 16 four year col-

leges combined. It is schemes like this that have starved our colleges for the past 13 years, forcing them to take more and more out-of-state students, which ultimately limits the number of Virginians that can attend these flagship schools. Those lucky enough to gain a slot, will be looking at significantly rising tuition and fees. Currently Virginia is investing approximately \$9,000/college student. By contrast, North Carolina, Michigan and California spend more than \$22,000/student.

In the area of K-12, our state has a constitutional requirement to fund what are referred to as the Standards of Quality. Until the slight increase in the sales tax last summer, the state never came close to its obligation. As a result local government has relied heavily on the real estate tax to make up the difference. The current Board of Supervisors in Fairfax County is considering reducing the real estate tax rate by 10 - 12 cents/hundred to offset the

increase in assessments. Much of this reduction will be made possible by a change in the tax structure in Richmond which vastly increases local government funds. Believe you me, I wished we could do all of this with no taxes.

I am a small businessman with businesses in Virginia and Maryland and am obligated to significant taxes. However, this is an urban state with urban problems and they cannot be solved without cost. We can take pride in the fact that Virginia was just recognized by Governing Magazine as "the best run state in America." This recognition came after we raised the sales tax last year from 4.5 to 5%. Beginning July 1, the sales tax on food will be reduced to 2.5%.

If we are to be successful in the future we must meet the needs of our growing population on all fronts - education, transportation, public safety and health & human services.

ADC book club read Pulitzer Prize winning author

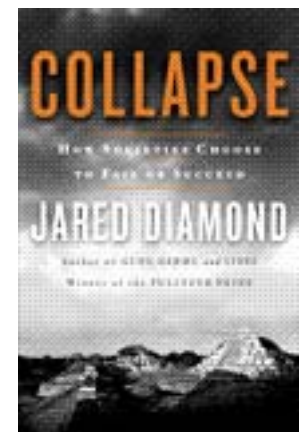

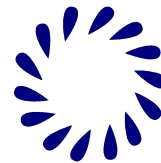
Our ability to maintain this Headquarters is completely dependent on your help. Contributions to the Leadership Circle
